An Ordinance Amending Title 13: Water and Sewer Rates and Charges

whereas the City of Georgetown, Illinois, a municipal corporation, acting through its corporate authorities, maintains the water and sewer systems for purposes of preserving the value of property and the safety of the residents living within the corporate jurisdiction of the City and preserving the peace, good order, and comfort, convenience, and welfare of the inhabitants of the City; and

WHEREAS the City of Georgetown, in order to maintain and operate its water and sewer systems, has the authority to establish rates and charges relative to the use of the systems.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

- Section 1. This ordinance amends Title 13, Chapter 13.08.010, Chapter 13.08.020, Chapter 13.16.660, and Chapter 13.16.670.
- Section 2. Subsection 13.08.010 (A) is hereby amended by replacing the language "six dollars and twenty-five cents" with the language "six dollars and seventy-five cents".
- Section 3. Subsection 13.08.010 (B) is hereby amended by replacing the language "twelve dollars and fifty cents" with the language "fourteen dollars and twenty-five cents".
- Section 4. Subsection 13.08.020(A) is hereby repealed, and the following is substituted in its stead:
- A. The rates of customers outside the corporate city limits of the city shall be twenty two dollars and twenty five cents (\$22.25) for the first two thousand gallons per month and eight dollars and seventy-five cents (\$8.75) for each one thousand gallons or part thereof supplied during the billing period in excess of two thousand gallons per month.
- Section 5. Subsection 13.16.660 (A) is hereby amended by replacing the language "ten dollars and fifty cents" with the language "eleven dollars".

Section 6. Subsection 13.16.670 (A) is hereby amended by replacing the language "nineteen dollars and ninety cents" with the language "nineteen dollars and sixty-five cents".

Section 7. Subsection 13.16.670 (D) is hereby amended by replacing the language "twenty six dollars and sixty cents" with the language "twenty six dollars and thirty-five cents", and further amended by replacing the language "nine dollars and seventy-five cents" with the language "thirteen dollars and eighty cents".

Section 8. The City Clerk is empowered to publish this Ordinance in pamphlet form.

Section 9. This ordinance shall be in effect beginning with the <u>Gucust</u> billing cycle.

Section 10. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, by a majority of the members of the City Council of the City of Georgetown, Illinois, at a regular meeting of the Council on the 5th day of June, 2023
