CITY OF GEORGETOWN, ILLINOIS ORDINANCE NO. 2024 - 142

AN ORDINANCE NAMING ROADWAYS

WHEREAS, the City of Georgetown, Illinois, a municipal corporation, acting through its corporate authorities, regulates the use and operation of roadways for the purpose of preserving the safety of the residents living within the corporate jurisdiction of the City, and preserving the peace, good order, and comfort, convenience, and welfare of the inhabitants of the City; and

WHEREAS, the City of Georgetown has the authority to establish names for roadways within its city limits;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

- **Section 1.** That the roadway shown and described on the attached "Exhibit A" is hereby named Water Drive.
- Section 2. That the roadway shown and described on the attached "Exhibit B" is hereby named Interurban Drive.
- Section 3. That the City Clerk is hereby directed to furnish certified copies of this Ordinance to the Vermilion County Clerk and the United States Postal Service branch office serving the area by certified or registered mail.

Section 4. That street name signed designating the names of the streets as assigned herein shall be erected and maintained by the City of Georgetown in accordance with the Illinois Manual on Uniform Traffic Control Devices.

Section 5. That the street names herein assigned shall not be considered as officially assigned until the street name signs are erected and approved by the City Engineer.

Section 6. This ordinance shall take effect upon its passage, or the soonest date thereafter as allowed by law.

Section 7. The City Clerk is empowered to publish this Ordinance in pamphlet form.

Section 8. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, by a majority of the members of the City Council of the City of Georgetown, at a regular meeting of the Council on the ____ day of ______, 2024.


