

Ordinance No. 2024-150

An Ordinance Amending Title 2:
Administration and Personnel

WHEREAS Title 2, Chapter 2.04 of the City of Georgetown Code of Ordinances (hereinafter the "City Code") currently specifies the compensation to be received by the Mayor of the City of Georgetown; and

WHEREAS the City of Georgetown now desires to amend Title 2, Chapter 2.04 of the City Code regarding the compensation for the Mayor; and

WHEREAS the City Council, after considerable thought and deliberation, has determined that it is in the best interest of the City of Georgetown to amend Title 2, Chapter 2.04 of the City code in the manner set forth hereinbelow.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Georgetown, Illinois, as follows:

Section 1. The above recitals are hereby incorporated by reference herein as express findings of fact.

Section 2. This ordinance amends Title 2, Chapter 2.04. To the extent that the provisions of Title 2 or any portion thereof are inconsistent with the provisions of this ordinance, the same are hereby repealed.

Section 3. Section 2.04.050(A) is hereby amended to read as follows:

"A. The mayor shall receive an annual salary of seven thousand dollars (\$7,000.00), paid in monthly installments. In addition to the annual salary, the mayor shall be paid sixty dollars (\$60.00) for each special meeting of the city council attended and twenty dollars (\$20.00) for each study session and twenty dollars (\$20.00) for each committee meeting attended."


Section 4. The City Clerk is empowered to publish this Ordinance in pamphlet form.

Section 5. Following its adoption, execution and publication, this ordinance shall take effect in May 2025, immediately following the May 2025 Mayoral election.

Section 6. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, by a majority of the members of the City Council of the City of Georgetown, Illinois, at a regular meeting of the Council on the 3 day of September, 2024


